Facts: Car No 43 did not drive around the chicane as described in the Road Book on page 1-71, pos.9.

Offence: Breach of Article 14.2 of the 2019 FIA Regional Rally Sporting Regulations.

Decision: time penalty of 20 seconds to be applied in Leg1

Reason: CoC report No 3.8 states, that the competitor No 43 did not follow the Road Book pos 9 on page 1-71. The representative of the competitor presented the onboard video clearly showing that the car was not making any attempt to stop and passed the chicane straight.

The Competitor is reminded of his right to appeal which is stipulated in the 2019 FIA International Sporting Code and in the 2019 FIA Judicial and Disciplinary Rules.
